WE RELEASED NEW EVIDENCE ON COMPREHENSIVE SEXUALITY EDUCATION IN FOUR COUNTRIES IN THE GLOBAL SOUTH, HELPING TO SHAPE KEY POLICY DISCUSSIONS (FOR EXAMPLE, THIS WORK INFORMED THE DEVELOPMENT OF A NEW SET OF SEX EDUCATION GUIDELINES BY THE NATIONAL POPULATION COUNCIL IN GHANA). WE LAUNCHED A 2017 UPDATE OF OUR LANDMARK ADDING IT UP STUDY, QUANTIFYING THE VALUE OF INVESTING IN CONTRACEPTION AND MATERNAL AND NEWBORN CARE IN DEVELOPING REGIONS. FOR THE FIRST TIME, THE REPORT SHOWED A DECLINE IN THE NUMBER OF WOMEN WITH AN UNMET NEED FOR CONTRACEPTION WORLDWIDE. THE FINDINGS PLAYED A KEY ROLE IN THE JULY 2017 FAMILY PLANNING SUMMIT, WHERE A NUMBER OF COUNTRIES PLEDGED NEW FUNDING FOR FAMILY PLANNING SERVICES AND SUPPLIES. WITH THE WORLD HEALTH ORGANIZATION, WE PUBLISHED NEW ESTIMATES OF THE LEVEL OF UNSAFE ABORTION FOR ALL REGIONS AND SUB-REGIONS OF THE WORLD; WE ALSO PUBLISHED MULTI-COUNTRY COMPARATIVE ARTICLES ON REASONS WHY WOMEN HAVE ABORTIONS AND THE CHARACTERISTICS OF WOMEN WHO HAD ABORTIONS.
